Federal law requires us to report the name, address, occupation and name of employer of each contributor whose contributions exceed \$200 in an election cycle. Individuals may contribute a maximum of \$5,600 -- \$2,800 for the primary election and \$2,800 for the general election. Multi-candidate PACs may give a maximum of \$10,000 -- \$5,000 for the primary election and \$5,000 for the general election. Contributions from corporations, foreign nationals, and federal government contractors are prohibited. Not printed at government expense.
