### JOINT FUNDRAISING NOTICE

Tim Scott Victory Fund ("JFC") is a joint fundraising committee composed of Tim Scott for America (the "Campaign Committee"), Tomorrow is MeaningfulPAC-FEDERAL (the "LPAC" or "TIMPAC-FEDERAL) and Committee to Elect Tim Scott Delegates, (each. a "Committee," and, collectively, the "Committees"). Any contribution to the JFC permissible under the Federal Election Campaign Act, as amended("FECA"), from contributors who have not exceeded their applicable Federal contribution limits, shall be allocated among the Committees pursuant to FECA and the formula set forth in this Notice.

Contributions Made by an Individual or Federal Non-Multicandidate Political Committee:

Individuals or federal non-multi candidate PACs may contribute up to \$16,600. Such contributions shall be allocated in the following order:

1. Tim Scott for America (2024 Primary Election Account) shall receive any contribution not exceeding \$3,300, provided such limits apply.

2. TIMPAC-FEDERAL shall receive the next contribution not exceeding \$5,000 annually.

3. Committee to Elect Tim Scott Delegates shall receive the next contribution not exceeding \$5,000 annually.

4. Tim Scott for America (2024 General Election Account) shall receive any contribution not exceeding \$3,300, provided such limits apply.

Contributions Made by a Federal Multi-Candidate Political Committee:

Multi candidate PACs may contribute up to \$20,000. Such contributions shall be allocated in the following order:

1. Tim Scott for America (2024 Primary Election Account) shall receive any contribution not exceeding \$5,000, provided such limits apply.

2. TIMPAC-FEDERAL shall receive the next contribution not exceeding \$5,000 annually.

3. Committee to Elect Tim Scott Delegates shall receive the next contribution not exceeding \$5,000 annually.

4. Tim Scott for America (2024 General Election Account) shall receive any contribution not exceeding \$5,000, provided such limits apply.
