Contributions to Catharine Baker for Assembly 2018 are not tax deductible for Federal or California tax purposes. The maximum legal contribution is \$4,400 per contributor, per election (the Primary and General Elections are separate elections). Individuals, busi- nesses, corporations and PAC contributions are permissible. Contributions from foreign nationals may not be accepted unless they have permanent residency status in the United States. California law requires political committees to report the name, mailing ad- dress, occupation and employer for each donor whose contributions aggregate \$100 or more per calendar year. Contributors who make \$10,000 or more in total contributions to state and local candidates, PACs, political party committees or ballot measures in a calendar year must file a California "Major Donor Committee" report.
