He will also oppose any attempt to use money from funds taken in by SB#1 for anything other than roads.



Larry Tack is running for County Assessor and says that he will establish an outreach program to inform Property taxpayers about the Homeowner's exemption available. He said that 40,000 residents in Monterey County are eligible but do not claim it. He will also look for property that is not on the tax roles.

A video was shown by the Travis Allen for Governor campaign. Travis Allen advocates that elected State officials serve in Sacramento for 3 months a year then go home and work with constituents. He would repeal the gas tax and Sanctuary State Status and establish Voter ID requirements.

View From The Edge Of The Crowd by Lee Schell
