Contributions to Valadao for Congress are not tax deductible as charitable contributions for federal income tax purposes. By law, the maximum amount an individual may contribute is \$3,300 (\$6,600 per couple) per election. Federal multicandidate PACs may contribute \$5,000 per election. Federal law requires us to obtain and report the name, mailing address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200 per election cycle. Contributions by corporations, foreign nationals, labor unions, federal government contractors, and minors under the age of 18 are prohibited
