Federal law requires us to obtain and report the name, mailing address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200 per election cycle. Contributions by corporations, foreign nationals (non-green card holders), labor unions and federal government contractors are prohibited. By law, the maximum amount an individual may contribute is \$2,600 per election. Federal multi candidate PACs may contribute \$5,000 per election.
